

Duke of Edinburgh's Award Scheme

I am doing my DofE Bronze Award and I was going to write about what it entails but now it seems even more appropriate to do so.

The Duke of Edinburgh set up this youth programme in 1956 and its popularity has spread over 144 nations. It is a great scheme that pushes you out of your comfort zone and gets you outside.

I am 14 years old and therefore I am in the age range for the Bronze Award. This has been organised through my school. It is made up of 4 categories which are volunteering, skills, physical and an expedition. As we've been in lockdown, it's been a bit tricky trying to take part in all of these activities but that's all part of the challenge! I chose to help with the parish newsletter for my volunteering, cookery for my skills, golf for my physical and the expedition will be organised by the school. As part of this, you have to set yourself targets, e.g. to practice getting a reasonable/improved score on different golf holes at Fingle Glen!

Before you start your 4 categories, you need to ask someone to be your assessor but it can't be a family member. You need to report your achievements to your assessor and they sign off on what you have done so that you have evidence of what you have achieved.

You can download an app on your phone where you log which activities you do and where you sign off your achievements.
Back in my Grandad's day, there was no such technology BUT he was given his Gold Award by the Duke of Edinburgh himself at Buckingham Palace!

The three awards are given depending on your age and they increase in difficulty.

- Bronze for those aged 14+ years
- Silver for those aged 15+ years
- Gold for those aged 16+ years

I'm writing to seek your views and support to help us to understand the current and future risks our communities face.

Like many organisations, Devon and Somerset Fire and Rescue Service has a range of statutory responsibilities we need to undertake in order to manage the risk to our communities.

At the same time, we have broadened our offer to partners wherever we can as we recognise that there are some complex issues, such as reducing the impact of mental health, that require leaders to work together to solve some difficult societal problems.

As such, we are undertaking our regular strategic review of the risks that we might face in the future and what the future landscape might look like in terms of infrastructure as well as societal trends.

This will be reflected in a Community Risk Management Plan (CRMP), formerly known as an Integrated Risk Management Plan (IRMP), which will run from April 2022 until 2027.

Before developing the draft CRMP, we are gathering views from people and partners across Devon and Somerset. These views will give us an understanding of what you and residents feel are local risks that we need to consider as well as perceptions of the fire and rescue service and its role within our counties.

We are capturing this through an online survey. It would be helpful if you could arrange for this to be completed and shared, as a higher number of contributions will give us better insight to make sure we're aligning our future plans with the communities we serve.

We will ensure that the results of this work are available to you as it may support your own risk planning approach and we also intend to start to build a rich dataset where we can layer data to inform trends (using non-personal data). This will inform future demand and capability mapping.

Once a draft CRMP is produced, we will consult with you and our communities on the content to check whether the understanding we've captured through our engagement work and data mapping has been accurately represented in the plan.

Your assistance is greatly appreciated and will ensure that we can continue to provide an effective and efficient fire and rescue service that remains focused on preventing incidents from happening but also has the right resources in place to respond to an emergency when required.

You Contain Multitudes

Cheriton Bishop Walking Group


We had a very successful start to our post lockdown walks with a long walk around the Meldon quarries and surrounding area a couple of weeks ago.

Earth Corner

Wildlife & Countryside Act 1981

The fine weather can be the spur we need to fire up our machinery and restore order to unruly trees and hedges. However, such activity could render you in breach of the law.

To help you keep your gardening activity within the law, here is a simplified version of the Wildlife and Countryside Act as it applies to bats and birds.

Breeding Birds

All wild birds are protected under the Wildlife and Countryside Act 1981 (as amended) from being killed, injured or captured whilst their nests and eggs are protected from being damaged, destroyed or taken. If you discover nesting birds in your work area, all activities likely to impact a nest area should be delayed until chicks have fledged.

To stay on the right side of the law, work on hedges and trees should only be carried out between the months of October and February.

Bat species and their breeding or resting places (roosts) are protected under the Wildlife and Countryside Act 1981 (as amended) and The Conservation of Habitats and Species Regulations 2017. They are identified as European Protected Species. Under these laws it is an offence to: capture, kill, disturb or injure bats (on purpose or by not taking enough care); damage or destroy a breeding or resting place (even accidentally); obstruct access to their resting or sheltering places (on purpose or by not taking enough care); or possess, sell, control or transport live or dead bats, or parts of them.

Seven species of bat are listed as being of principal importance, in the Secretary of State's opinion, for the purposes of conserving biodiversity. Under section 41 (England) of the NERC Act (2006) there is a need for these species to be taken into consideration by a public body when performing any of its functions with a view to conserving biodiversity.

These are Barbastelle, Bechstein's, Noctule, Soprano Pipistrelle, Brown Long-eared, Greater Horseshoe and Lesser Horseshoe and are the subject of National and Local Biodiversity Action Plans. Activities that can affect bats include (from GOV.UK):

- renovating, converting or demolishing a building
- cutting down or removing branches from a mature tree
- · repairing or replacing a roof
- · repointing brickwork
- · insulating or converting a loft
- installing lighting in a roost, or outside if it lights up the entrance to the roost
- removing commuting habitats such as hedgerows, watercourses or woodland
- changing or removing their foraging areas
- · using insecticide
- treating timber

It should be noted that in any building, individual bats could occasionally roost or move in at any time, and the following approach is recommended:

- Prior to the start of works, all site staff should be briefed that bats can move into a building at any time and may be encountered during works.
- If bats are found unexpectedly during works, work should stop immediately and Natural England (0300 060 3900) or Western Ecology (0800 622 6828) must be informed.
- Any bats found that are exposed and vulnerable should be protected from the elements and predators (particularly cats). You may need to contain the bat in a shoe box or similar sized container (with holes punched in the lid). You should not handle bats with bare hands.

Authorities such as the Wildlife and Crime Officer within Devon and Cornwall police, DEFRA, Natural England and local authorities are taking wildlife protection very seriously so please take care when carrying out your gardening or building activities over the Spring and Summer months.

Please also consider getting advice from an ecologist when planning loft conversions or changes to soffit boxes to minimise the risk of breaking the law or causing an impact to both nesting birds and roosting bats.

In the Garden

Beautiful May!

May is such a beautiful month in the garden. It is the month of bluebells and apple blossom, cow parsley along the roadsides and the fleeting exotic bloom of irises. Tulips planted in the short dark days of late autumn, are at their glorious best. The laburnum lights up the greyest day with its golden racemes and allium pop up as star performers. Clematis Montana clothes whole walls with an amazing display for about 4 weeks. It can be pruned to its allotted space after flowering.

During May it should be safe to uncover any tender perennials that have been protected during the winter. There still might be cold, frosty nights though so keep some fleece ready to cover vulnerable plants.

Box hedges are best trimmed early in the season as they dislike being pruned hard back. They respond much better to a gentle early cut. The clippings can be used as cuttings if they are 3" or more. Remove the lower leaves, insert them into a pot of compost and leave them in a shady place under a polythene bag.

Now that herbaceous perennials such as delphiniums, are growing rapidly taller, make sure they have adequate support. If you have prunings of birch or hazel, these look good

until they disappear under the emerging foliage. Otherwise, canes and string work well.

Don't be tempted to cut back the foliage of spring bulbs. They need to be left for at least 6 weeks after flowering to allow the bulb to build up energy ready for next year's display.

If you are enjoying spring flowering biennials such as forget- me-nots and wallflowers, remember to sow seeds for next year. They can be sown in rows in a nursery bed ready to plant out in the autumn.

Tomato plants can be put into their growing positions in the greenhouse as other plants are put outside. In the vegetable garden, beans can be sown or planted out after a few twiggy branches are put in for them to climb up. Sweetcorn and courgettes like a humus rich soil so that can be prepared ready for plants to be planted out at the end of the month. Keep sowing sweet pea seeds so that you have a succession of scented flowers.

Keep feeding the birds as they will help control pests such as aphids and slugs as well as providing much entertainment!


Easter Egg Hunt

Church Messages

Bank Holidays in May

May is unique in having two Bank Holiday Mondays, for many people it offers the prospect of two long weekends which may translate into a holiday away. However, with current restrictions, these may not be able to offer quite so much freedom to go away.

The Early May Bank Holiday returns to its traditional place, the first Sunday in May. If you remember it moved to a Friday to celebrate the 75th anniversary of VE Day. I am not sure quite what its origin is, it could be a celebration of the beginning of summer and would then have a connection with Maypoles and Morris Dancers. Or it could be related to Labour Day celebrations which celebrate the achievements of workers and the establishment of workers' rights. It seems a good connection to give workers a day off.

I was surprised to learn that Bank Holidays were introduced to allow Banks to close on public holidays, they had been forced to stay open to allow payment to continue even on public holidays. They came into being in 1871 but only offered four bank holidays, Easter Monday, Whit Monday, First Monday in August and Boxing Day.

I was also surprised to learn that there were thirty-three public holidays for saint's day and religious festivals. It was considered excessive and was reduced to just four in 1834. Again surprisingly, we have the second-fewest public holidays in the world, only Mexico has fewer!

The second Bank Holiday originates from Whit Monday, ie the Monday after

Whit Sunday or Pentecost. Pentecost is a moveable date linked to fifty days after Easter. This year it would be May 23rd giving the Bank Holiday on Monday 24th May. However, the connection with Whitsun was cut in 1971 and the bank holiday is now the last Monday in May. So, the bank holiday is actually on 31st May. It is much easier to have the last Monday in May than work out when fifty days have passed after Easter. However, sometimes that which is easy is not always good for us.

The Pandemic has reminded us that what was comfortable and easy was not always good for us.

It has become very easy to be selfish and forget about our neighbour.

We have been reminded of how important it is to be a good neighbour.

We are reminded of the importance of community and pulling together in adversity.

I would want to add that our relationship with God is important for both our wellbeing and our awareness of the needs of those around us. We may have fractured or forgotten some of our connections. Easter and Pentecost promise that they can be restored and renewed.

Minutes of the Parish Council Meeting

Held on the 12th April 2021 using virtual Zoom technology as permitted by the Local Authorities and Police and Crime Panels (Coronavirus)

Present: Cllr Milton (Chair), Cllr Ball, Cllr Benjamin, Cllr Edwards, Cllr Salmon, Cllr Tomlinson,

1. To receive and accept apologies: Apologies were received from Cllrs Coren (MDDC) and Penny (MDDC)

- 2. To receive declarations of interest to receive declarations of personal and disclosable pecuniary interests in respect of items on the agenda: No interests were declared.
- 3. Public Discussion an opportunity for members of the public to make representations, answer questions and give evidence in respect of any item on the agenda: A representative of Airband gave a presentation and answered questions on the service that Airband could provide for residents of Cheriton Bishop. In partnership with Connecting Devon & Somerset, Airband has been commissioned to provide fibre to premises broadband to improve connectivity in rural Devon, including Cheriton Bishop. Those interested should register their interest on the Airband website. Airband will carry out a free survey to check there are no issues with providing a connection. The project is expected to be completed by the end of October 2021. The expected cost for residents is a £30 installation fee and then a monthly fee of £30 £35 per month. The expected speed will be between 40 and 100 MBit.
- 4. Allotments to receive an update on progress with the allotment project: The clerk reported the landowner is in touch with those waiting for an allotment and is keeping them informed. There are some delays and it is now hoped to start work on the site in the autumn so that planting can begin in Spring 2022. The clerk has spoken with and taken advice from the parish clerk in another parish in which the landowner lets allotment land direct to the allotment society, without the involvement of the parish council. The clerk is to speak to the planning officer at MDDC for further confirmation of planning issues.
- 5. Community Broadband to consider how to raise awareness in the parish of broadband providers which may offer an improved service: The clerk will forward a copy of Airband's presentation to Councillors for consideration.

Dog Fouling – to discuss the continuing problem of dog fouling in the village and consider associated action: Councillors discussed emails received from 2 parishioners who are very concerned about this issue which is getting worse, especially at Glebelands. Cllr Ball explained action being taken in Menheniot parish, which asks people to keep a diary of incidents witnessed (when and where). It was resolved to take the following action: clerk to take advice from MDDC's Dog Warden; clerk to obtain the pink spray that has been used in the past so that dog owners know the issue is being monitored; posters

asking owners to pick up and explaining the fines for not being picked up to be put up around the village; posters to be put up asking people to keep diaries so that a pattern may be found that can be reported to the MDDC Dog Warden to assist him/her in witnessing an incident. Maps showing location of dog bins to be put up around the village. Clerk to reply to the parishioners. Cllrs also discussed problems with stray dogs around the parish and aggressive loose dogs chasing joggers.

- 12. Wildlife Wardens to consider introducing a scheme for Wildlife Wardens in the parish: Cllr Westcott reported that Devon Wildlife Trust want to help with this project but are not able to do so at present. It is important that MDDC own the project (even if community groups raise funding) so that all parishes in the district can benefit. To go back on the agenda when there is more news.
- **13.** Glebelands Play Area to update on the play area and discuss on-going issues: The clerk awaits hearing from MDDC regarding the completion date for the lease. Clerk to arrange sign for the gate/fence with contact details (clerk) for reporting issues at the play area.
- 14. Highways Assessment to consider Cllr Ball's updated Highways Assessment and agree next steps: It was resolved that a letter regarding parking on pavements will be sent to parishioners. Clerk/Cllr Ball to action. Cllr Ball will put his assessment on the Facebook page for comment by parishioners.
- 15. Operations London/Forth Bridge to consider whether to arrange for the PC website to be blacked out when the need arises: It was resolved that the action taken on the recent sad occasion of the death of HRH Prince Philip, The Duke of Edinburgh (a message of condolence on the PC website and FB noticeboard, a link to the Royal Family Book of Condolence and the observance of a one minute silence at the start of this meeting) was appropriate.
- 16. Skate Ramp to consider the installation of a skate ramp on the Village Green: Councillors discussed whether the village green was a suitable site, bearing in mind the terms of the Licence and the slope of the ground. Councillors discussed how to provide activities for teenagers in the village. It was resolved to ask teenagers on Facebook for their ideas. Cllr Salmon to action and report back. Cllrs discussed the possibility of renting a temporary skate ramp for a short period.
- 17. Climate Change to receive an update on Climate Change initiatives: Cllr Wood reported that the wildflower seeds have been sown in the newly prepared beds at the Village Green. The 2 new picnic benches have been delivered and Cllr Wood and a volunteer will paint them shortly. There is now an old Wendy House on the Village Green which contains games equipment for those who want to use it. A resident is putting building waste on the village green. Clerk to write to ask the resident to stop doing this.
- **18.** Social Media to receive an update on PC social media activity: Cllr Tomlinson reported that the PC FB group now has 85 members of which 58 are active. All councillors need to think about posting engaging content. PDFs are not accessible for mobile phone users so Cllr Tomlinson has been posting agendas and minutes by alternative means.
- 19. Roads & Footpaths to receive an update on roads and footpaths in the Parish: Cllr Wood reported that signposts have rotted on Footpaths 6 & 7 and that a footbridge is needed on 6. She has reported these on the DCC website. Cllr Tomlinson reported that there are signs missing on Footpath 11 and Bridleway 12 and that dog access on 3 stiles on Footpath 16 has been nailed shut. These issues to be reported on the DCC website. Cllr Tomlinson commented that Bridleway 12 ends on the C50, which is quite dangerous.
- 20. Glebelands Play Area item withdrawn as dealt with under 13 above
- **21. Newsletter to receive an update on newsletter activities:** Cllr Edwards reported that 250 copies are being printed as there has been higher uptake online during the pandemic. The newsletter has sufficient volunteers at present.
- **22. Repairs & Maintenance to consider any repairs and maintenance needed for PC assets:** One of the old circular picnic benches on the Village Green is beyond repair. Cllr Wood will arrange for it to be disposed of.

They had been nearer Four Ways Cross before but had to be moved back as the landowner objected. In view of parishioners' safety concerns Highways might agree to move the signs again.
